GSWW Resident and Day Camps, including Volunteer Led Day or Twilight Camps and Community Sleep Away Camps:

Girl Scout destinations Trip:

Available to girl members of GSWW

Financial assistance (up to \$600) will only be available in the year that the trip occurs

Must be accepted by destination trip before applying for financial assistance.

Submit a copy of acceptance letter with Financial Assistance Request Form.

Any assistance granted will be sent to the sponsor of the destination to help pay for the event fee.

GSWW Travel Opportunity:

Available to girl members of GSWW and adult members of GSWW who are selected to chaperone the trip

Financial assistance (up to \$600) will only be available in the year that the trip occurs

Must be registered for trip before applying for financial assistance

Trip registrar will be notified of any assistance granted.

Troop Travel:

Available to girl members of GSWW and adult members of GSWW who are required to participate for adult to girl ratios

Financial assistance (up to \$600) will only be available in the year that the trip occurs

Trip must be for a minimum of 3 nights

Financial assistance can be used for the following:

*Commercial or public modes of transportation

*Lodging

*Program fees (such as GSUSA events, World Centers, GSWW or other council's events, and travel packages)

A copy of the **approved** Intent for Extended Travel Application and/or Travel Application for Extended Trips form must be submitted with financial assistance request

Financial assistance must be paid directly to the vendor for lodging, commercial transportation or program fees or to the troop as reimbursement when receipts are submitted **before** the first day of the trip
